Contest Rules and Regulations

1. **MISSOURI STATE FAIR IDOL** contest is open to qualified persons in Missouri who are at least sixteen (16) years of age. Proof of age may be required in order to be qualified. An entry form must be submitted to the Missouri State Fair, or to a participating media partner. Entry forms are available on the Fair's web site listed under special contests in the Premium Guide: <http://www.mostatefair.com/premium.html>, or at Better Country KIX 105 KXKX.com.
2. Members and immediate family members of the Missouri State Fair, media partners and their vendors are not eligible to participate in this contest. This includes, but is not limited to, spouse, parents, children, and/or relatives residing with such parties.
3. To qualify for this contest, a person must participate in one of the qualifying karaoke contests sponsored by participating broadcast outlets or submit an audition video (VHS or DVD formats only) to the Missouri State Fair, Attn: Missouri State Fair Idol. Deadline for submission videos is July 10, 2008.
If submitting audition video: Length of material is not to exceed 3 minutes. Tapes/discs will not be returned. Tapes should consist of authentic vocal performance to an accompaniment tape/CD. No live instrumentation is allowed by the applicant or other individuals/groups. No live background vocals are allowed. No explicit content/lyrics are allowed. Name, address, DOB, day-time phone number & e-mail address must be provided.
4. Contest announcements made by participating broadcast outlets. A final Idol will be presented the closing Sunday of the Missouri State Fair. One (1) qualifying contestant will be selected during the preliminary competition held daily, August 7-16, at 4 PM, at the Budweiser Tent on the Missouri State Fairgrounds. Thus, a total of ten (10) preliminary winners will be competing in the finals on Sunday, August 17, at 2:00 PM.
5. Individuals who qualify to compete at the Missouri State Fair must provide their own accompaniment CD. Song selection must be the same as that used to qualify.
6. Qualifying contestants must be available from 4 p.m. through 7 p.m. each preliminary evening, August 7-16 and from 1 p.m. through 7 p.m. the day of finals, August 17.

7. The qualifying contestant chosen each day of the Missouri State Fair MUST be the one to appear at the Missouri State Fair Final Idol on August 17. Spouses, children, relatives, etc. will not be allowed to show verification for the qualifying contestant.
8. To be eligible for the grand prize, qualifying contestants will be required to sign a written acknowledgment and release, authorizing the Missouri State Fair, and media partners to videotape and use his/her name and likeness during and after the contest.
9. The Missouri State Fair, and media partners are not responsible for any technical difficulties associated with audio transmission, cable transmission, and master control board malfunctions. This includes, but is not limited to, operator technical malfunction, cellular interference, technical or atmospheric conditions that disrupt the completion of the daily qualifying and Final Idol performance or any technical difficulties, which may prohibit the execution of the contest.
10. In the event of technical difficulties, contestants may be allowed to continue their performance after the technical difficulties have been resolved.
11. In the event that any qualifying contestant does not meet the necessary qualifications stated within these contest rules, there may be less than ten (10) finals-qualifying contestants selected throughout the contest.
12. The Missouri State Fair reserves the right to disqualify any person who does not comply with any of the official rules stated herein.
